

### Today's Take-Aways

• Following direction from the Champlain Region Incident Command's Infection Protection and Control Network and as a result of increasing evidence of the asymptomatic spread of COVID-19, PRH has implemented additional requirements for universal masking. In addition to the Phase 1 Universal Masking Guidelines released on March 31<sup>st</sup> 2020, we are now implementing Phase 2, which will include:

- All staff and Physicians being required to don a mask upon arrival to, and for the duration of their time in, any clinical department.
- Where physical distancing is challenging, all staff and physicians must wear a mask.

Additionally, patients and visitors will be provided with masks to wear. In order to make best use of PPE, we will be reaching out to those in the community who are making fabric masks and asking for donations for use by our patients and visitors.

• A mandatory eLearning module on COVID-19 safety principles and PPE has been launched today. This is to be completed by all staff and physicians.

• Please note that PRH will no longer be collecting used surgical/procedure masks for potential reprocessing.

• We will be issuing a press release this week on the importance of using Renfrew County emergency departments for urgent health care matters or symptoms that would normally bring someone to the ED. This is in response to an increased number of patients presenting with conditions or symptoms that are more acute as a result of their having postponed or avoided a visit to an ED.

• Based on geography, PRH has been assigned a total of eight retirement homes and two longterm care facilities within our region to connect with and support should the need arise. A small number of our staff have now been redeployed to provide assistance at two of these retirement homes. In Renfrew County, approximately 50% of homes have now swabbed all of their residents and staff for COVID-19 with the remainder of facilities expected to be completed by the end of this week. By the end of next week, all homes are expected to have received assessments by Public Health and Infection Prevention and Control.

### **Today's Take Aways...Continued From Front**

• PRH is receiving an allotment of 11 new acute care beds. These beds were purchased by the province to support the expected surge of COVID-19 cases and are now being allocated to hospitals, like ours, who created additional COVID-19 capacity. These new beds will replace some of the older beds on our Medical and Surgical units.

• Just more than 120 swab tests of COVID-19 symptomatic staff and their family members have been taken to date at PRH with all having come back "negative". All staff and physicians are to be congratulated for self-monitoring and for monitoring their household members, self-isolating when required and of looking after themselves and their families.

• Following COVID-19 audits by Occupational Health and Infection Prevention and Control there will be new signage posted in break rooms and other common areas to ensure safe room set-ups and maximum occupancy limits along with guidelines that reinforce safe physical distancing.

• A reminder to all that there are specific processes in place to report concerns regarding health and safety at PRH including the Internal Responsibility System and RIMS reporting mechanism.

• Staff will notice a change to the celebration tickets on their Lean boards with an emphasis now on gratitude and the celebration of those who are doing things during the COVID-19 pandemic that deserve special thanks and recognition. Everyone is being encouraged to provide a bit more detail on the new tickets identifying the reason why an individual is being recognized.



• COVID-19 patients in our care: 2 probable in the ED and 10 probable on 2A. There are no positive cases at PRH.

• In Renfrew County, there have been 18 laboratory confirmed cases to date, and one death. To date, a total of 2,267 people have been tested, with 171 still under investigation. For the latest Renfrew County information on COVID-19, please visit www.rcdhu.com.
